When there are communities that depend on each other, why are we splitting them up? They have taken *ages* to produce these maps, only to give us a few days to evaluate them. And when we do get them, they are low resolution. How are we even supposed to provide meaningful feedback to the commission when we aren't given a viable opportunity to do so?

When I voted for the Redistricting Commission reform in 2015, I was voting for what I thought would be a non-partisan commission. The commission, intentionally separate from the legislature, should be there to make our maps *fair*. The problem I see in the legislature controlled by the Ohio GOP is that they simply don't care about the law that is telling them that what they are doing is unconstitutional, because no one is holding them accountable. If we have a commission that works the way it's supposed to, the way it was intended to when I supported it in the past, we would be in

good shape, but it continues to be hijacked by people who don't care about the community.

When we create districts that are 70% one way or another, no one is holding their representative accountable, you are worried about being primaried, not worried about representing the people they work for.

Even citizens trying to stay actively informed and involved, like those who showed up and participated last night, have expressed frustration and confusion about the lack of information surrounding this process. This process is confusing and deliberately not accessible to many Ohioans who have arguably the biggest vested interest in how we draw these districts, and they are concerned and they do care. If Ohioans don't even understand the process, how can we expect them to join in the conversation? How are we supposed to, in good conscience, say that these maps have had thorough consideration when it has been less than a week since these maps have even been made public?

Beyond just meeting the numbers, statistical indexes, and baseline requirements, we really do need to consider the communities we are drawing lines through.
